1. GENERAL INFORMATION ABOUT THE COOKIES

- 1.1. Cookies are small text files which an internet browser may store in your device upon instruction of the website when you visit the website. They serve for ensuring functionality of certain components of website or for example for the websites being able to better record website traffic.
